## General Show Rules:

**8 & Under may have spotters in the ring. Novice Classes may have spotters in the ring.**

**Trail Pleasure:** Horses may not show in Lite Shod or Plantation Pleasure classes but may show in TWH Pleasure and Easy Gaited Pleasure classes.

**Country Pleasure:** Horses may not show in Trail Pleasure, Lite Shod or Plantation Pleasure classes, but may show in Easy Gaited Pleasure classes.

**Novice:** New or returning to showing after a more than 3 year absence in 2010.

**Optional Tack (OT):** Either Western tack and attire or English tack and attire. Not a combination of both.

**Youth:** Youth 11 & under must have protective headgear. Youth between 12 & 17 are encouraged to wear protective headgear.

**Casual Dress:** Long pants, collared shirt, boots with heels.

**TWHBEA Versatility** rules apply

**SHOW** shoeing rules apply

All horses must have a negative Coggins; January 1 - December 31 of current year.
